




The UNFPA GBV Response and Prevention Programme works in cooperation with the Office of the Deputy Prime Minister for European and Euro-Atlantic Integration, the Ministry of Social Policy, the Ministry of Internal Affairs, the Ministry of Health, the National Police, and supports integration of all new services into the network of municipal, local, and state services.

UNFPA funds and supports a vast specialized 26 shelters, network of GBV services, including: 26 shelters, 43 crisis rooms, and 46 daycare counselling centres. To bolster complement and service network, UNFPA, with Ukrainian partnership has created tailored authorities. non-specialized initiatives including Survivor Relief Centres. 'Vilna' women-friendly spaces, and 'VONA' career hubs, which will eventually be integrated into the national Úkrainian ĞBV system.



239,5 Metric Tons of Inter-Agency Reproductive Health Kits have been delivered since the start of the fullscale invasion to fill critical gaps in supplies and equipment in hospitals with perinatal centres.


During December, **UNFPA** distributed 4,5 metric tonnes of **IARH** Kits to 6 hospitals in Cherkasy, Rivne, Ivano-Frankivsk, and Odesa oblasts.



During December, UNFPA made significant progress in its capacity enhancement efforts, equipping national healthcare professionals across Ukraine with the necessary knowledge and skills to provide quality and life-saving reproductive health services.

More than 1,600 participants benefited from learning activities.

**Professionals SDPs** conducted a total of 6,294 medical consultations, including clinical management of rape (CMR). Since the start of service délivery, UNFPAsupported **SDPs** have provided **CMR** for 60 incidents.

### **DIGNITY KITS DISTRIBUTION**

48,000

Almost 48,000 dignity kits have been distributed to, mainly, women since March 2022.

Women and girls affected by the war in Ukraine need care and support during this difficult time. UNFPA Dignity Kits (DKs) contain carefully selected essential items to ensure menstrual hygiene, comfort, and are also tailored to the needs of pregnant and lactating women. **6,651 dignity kits were distributed in December to vulnerable people.**

### STRENGTHENING THE RESILIENCE OF YOUNG PEOPLE

The "Energy of Your Future" training programme evolved in 2022 to address critical skill gaps among vulnerable adolescents, focusing on mental health, war-trauma coping, and career planning. Developed in collaboration with UNFPA and the Ministry of Education and Science of Ukraine, the programme transitioned to a community-oriented approach within EU4Recovery, forming a network of 47 trainers in Dnipro, Poltava, and Chernihiv regions equipped to empower adolescents aged 14-17 with key life skills.

The community of trainers played a pivotal role in organizing six local day camps for teens in October and December 2023, engaging 126 young participants, providing them with essential life skills. The programme's adaptability and emphasis on personal development contribute significantly to the resilience of both individuals and communities, fostering leadership qualities and effective collaboration among teenagers.

#### INTER-AGENCY COORDINATION

### GBV Area of Responsibility (GBV AoR)

- The December 2023 report, 'Service Barriers Faced by Male Survivors of Sexual Violence in Ukraine', issued by the GBV AoR, underscores the challenges male survivors encounter in accessing GBV services and outlines efforts to address their needs. The report, a result of a survey led by the GBV AoR Working Group on the Needs of Male Survivors of Sexual Violence, chaired by the Women's Refugee Commission, DRC, and INTERSOS, prompted the issuance of a contextualized 'Guidance Note on Working with Male Survivors of Sexual Violence'. The note aims to enhance the operational effectiveness of GBV AoR partners in Ukraine.
- In December 2023, a total of 710 participants representing 278 organizations, institutions, and offices engaged in seven specialized training sessions on GBViE.

## Sexual and Reproductive Health Technical Working Group (SRH TWG)


- As part of the 16 Days of Activism Against Gender-Based Violence, the No One Left Behind Workshop addressed barriers
  to healthcare for survivors of GBV. Discussions expanded to broader challenges in SRH, focusing on vulnerable groups. The
  workshop aimed to collaboratively explore solutions for dismantling barriers and ensuring equitable access. By fostering a
  shared dialogue among diverse stakeholders, the event sought to catalyze collective efforts for an inclusive and supportive
  healthcare environment.
- The **SRH TWG** offered technical support to a cervical cancer prevention project using WHO-recommended HPV screening technology. SRH TWG partners will collectively execute the project in the Dnipropetrovsk oblast, emphasizing the group's dedication to leveraging technical expertise and fostering collaboration to tackle health issues. Their goal is to advance screening techniques, engage various stakeholders, and enhance women's reproductive health in the region by timely prevention and detection of cervical cancer.

### LATEST NEWS FROM UNFPA IN UKRAINE

- In the aftermath of recent Russian aerial attacks, UNFPA's dedicated teams of <u>Survivor Relief Centre and PSS mobile</u> teams were on the ground in Lviv, <u>Odesa</u>, <u>Zaporizhzhia and Dnipro</u>, extending vital support to those affected by the extensive attacks. In the face of heartbreaking devastation, our shared resilience becomes a beacon of hope.
- The Government of Japan has co-funded the procurement of 70 tonnes of critical pharmaceuticals and medical supplies for 93 maternity hospitals across Ukraine.

## **UNFPA UKRAINE FUNDING STATUS (AS OF 31 DECEMBER)**

- UNFPA Ukraine emergency appeal for 2023 for US\$ 74.1 million seeks to provide life-saving GBV and SRH prevention and response services to address the needs of women and girls in Ukraine.
- As of 31 December, the UNFPA Appeal for Ukraine was almost 99 per cent funded, which includes funds committed for ongoing projects. This includes support from the USAID's Bureau for Humanitarian Assistance (BHA), Sweden, Australia, Norway, the United Kingdom, France, Korea, Denmark, Spain, Finland, Belgium, the EU (DG-ECHO, DG-NEAR), CERF, Netherlands, Ireland, OCHA-Ukraine Humanitarian Fund, Japan, Canada, Iceland, Estonia, Czech Republic, Austria, the UN Partnership to Promote the Rights of Persons with Disabilities (UNPRPD) and Portugal. Funding from the private sector and private individuals is also included.
- UNFPA requires long-term flexible funding to respond to the needs of the population in Ukraine and neighbouring countries. All levels of funding are solicited.
